### **QUOTATION NOTICE**

Sealed quotations are invited from the qualified advertisement contractors (excluding blacklisted contractors and contractors who are in litigation with MSRDC) presently operating with MSRDC in the prescribed form of offer attached herewith for the work of Maintenance of Beautification / Landscaping below flyover with utilization of space for display of advertising below Vashi flyover for three months period. The contract period of three months shall be further extended at the discretion of MSRDC. The work consists of maintenance of existing beautification below Vashi flyover and repair/modification of the existing glowsign boxes, if required, as per the method of erection given elsewhere in this document, considering safety of the flyover, moving vehicles, pedestrians underneath etc. and further utilizing the glowsign boxes for display of advertisement for three (3) months contract period after obtaining necessary approvals, permissions, licenses etc. It may be noted that the contract period for display of advertisements is inclusive of time required for obtaining necessary permissions/approvals/licenses etc. from the competent authority, repair / modifications of glowsign boxes (if required). Further forthwith upon expiry of the contract period of 3 months or extended period, if any, the space below Vashi flyover including the 99 glowsign boxes shall be handed over to MSRDC by the Contractor in proper utilizable condition. The glowsign boxes shall be erected in such a manner so as to comply with the local laws and guidelines of the respective competent authorities. The contractor should quote his offer in terms of total three months compensation for Maintenance of Beautification / Landscaping below flyover with utilization of space for display of advertising below Vashi flyover in the Form of Offer attached herewith. The compensation for extended period of contract, if any shall be paid upfront immediately upon issuance of Letter of Extension by MSRDC. The offer can be submitted on or before 17/06/2019 by 3.00 P.M in a sealed envelope along with Quotation form, Form of Offer and other relevant documents in the office of the General Manager (Admn), MSRDC Ltd., K. C. Marg, Bandra (W), Mumbai – 400 050. All the pages of the quotation form, quotation notice must be signed / initialled by the person signing the offer and same may be submitted along with the offer. It will be opened on the same day at 4.00 pm, if possible. The hoarding structure on the site is owned by MSRDC and same is being offered on as-is-where-is basis and as-is-where-as condition.
